## Writing your Will

When writing your Will it is important to obtain legal advice, to ensure that your Will is valid and that it will achieve your wish. It is also important to consider the needs of your family when making your Will, and let them know if you decide to leave a bequest to the eviDent Foundation.

The eviDent Foundation cannot provide you with legal advice, but we have provided suggested statements as a guide to assist you with the process.

There are many ways to make a bequest; the most common is a specific bequest of a specified amount of money or an asset. You can help us to achieve your wish by keeping your bequest quite general.

### Specific bequest

For a specific bequest, you bequeath a specified amount or an asset, e.g. shares, or property.

#### Residuary bequest

For a residuary bequest, you give a portion of your residuary estate, that is, what remains after all other gifts and costs have been paid.

#### General purposes

For a general purposes bequest, the eviDent Foundation will use the funds to the greatest need at the time. If you choose this option, we suggest that you use one of the following statements in your Will:
